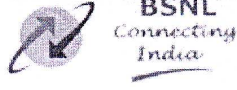


Sir,

This has reference to your letter No. BSNLEU/2014-15/1 dated 30/6/2014 giving notice for one day Dharna on 11/7/2014 in support of your demands. The Circle Management has taken immediate necessary action, as listed below, on the issues raised in the letter.

- 1) Instructions have been issued to all Heads of SSAs to meet the District Representatives of Recognized Union(s) and to settle the issues / demands amicably.
- 2) Instructions have already been issued to SSAs to receive staff grievances on all Wednesdays between 1430 to 1630.
- 3) The issue of short supply of stores like cable, telephone instrument, modem, etc. can be discussed in the "Works Committee" meetings. Instructions have already been issued on 2/7/2014 to all Heads of SSAs for conducting the Works Committee Meetings periodically as per the guidelines of Corporate Office, New Delhi, which will be monitored by Circle Administration.
- 4) The Committee set up, to analyze the issues raised relating to settlement of medical bills and to submit recommendations to Administration, is proposed to meet in the 2<sup>nd</sup> / 3<sup>rd</sup> week of July 2014. The CS's of BSNLEU & NFTE-BSNL/ members of the committee have been addressed regarding the meeting and to forward their points.

In view of the above, I would like to make an appeal to you to withdraw the notice for one day "Dharna" on 11/7/2014 and have the issues and grievances resolved amicably through negotiations.
