Circle Council Items

Review of 21st Circle Council pending cases.

New Cases:-

1. ERP Issues

- a. Correction of data- Family Particulars and other service particulars
- b. Setting Right GPF Balance- Sanctions as per eligible criteria
- c. Depositing Union Subscription to the respective level on or before 5th of every month with SSA wise break up particulars
- d. Depositing Loan installments to the respective banks in time and returning back to the concerned employee if remitted after expiry of loan
- e. TDS issues
- f. Leave Encashment on the next day of retirement
- g. Leave entry in service books- Mechanism

2. Presidential Order Cases

There are still cases need to processed for issuing PO on their expiry of Punishment period. Particulars may be obtained from SSAs and needful may be done for issuing Pos.

3. Off net Calls

Our Phone mechanics and other employees having direct dealing with subscribers on service matters contacted the customers having other network connections using Prepaid SIM CUG Rs 200. This practice was in vogue till 2 or 3 months before. Due to technological advancement (IN), the facility was stopped. On our queries, we were informed that the order for providing Rs 200 facility Sim is, not for any off net calls and moreover it involves IUC Charges. Now as per the new direction of TRAI effect from March 2015, IUC charges are going to be nil on those calls. Restoration of earlier position that is access to off net calls (within that Rs 200) may be examined on service interest. And also, provision of STD facilities may be extended.

4. Setting Up Business Core Committees

With the aim and hope of making every SSA a profitable Business centre, a core committee comprising all those Volunteers who put their heads together may be formed in every SDCA as well as SSA. Innovative ideas, best business solutions, finding green areas may be viewed and appreciated in the committee. It may be coordinated with works committees to augment business and as well quality of service.

5. Implementation of Project Vijay in Tamilnadu Circle

Corporate office issued orders for implementation of Project Vijay in order to reduce the expenditure. We understand that some of the SSAs have implemented and it is proved that the expenditures on Watch man duties have been reduced. For eg., Virudhunagar and Cuddalore SSAs. Hence, circle council may take a decision to implement Project Vijay in all SSAs to reduce the expenditure.

6. Renewal of HRA cases in Tamilnadu Circle.

HRA renewal cases of Chinnampalayam (Coimbatore SSA) and Somarasanpettai, Mutharasanallur, Manachanallur, Samayapuram, Pitchandar Kovil, Nagamangalam and Guntur (Trichi SSA) from 2011 are pending. Circle council may take a decision in this regard.

7. Supply of power shoes

The staffs working in NWOP sections are handling power area. Hence it is requested to supply power shoes to them to avoid any casualty.

8. Allotment of Sims.

We request that, more number of SIM cards may be supplied to our own CSCs. It is understood that Franchisees are getting ample number of SIM cards, where as CSCs are suffering due to shortage of SIM cards. In this competition era, our CSCs should be equipped with full products, so that image of BSNL will flourish.

9. NEPP to left out officials.

NEPP order was issued on 23.03.2010. Corporate office categorically issued orders that NEPP should be awarded to all officials within a stipulated time. The officials will get 1st promotion from 1.10.2004 and second promotion from 01.10.2011. In Tamilnadu Circle, still the eligible officials were not provided NEPP orders. For an example, in the cadre of Sr. Accountants, are waiting to get NEPP even though they are eligible. Hence it is requested to issue NEPP to left out officials.

10. Furnishing the report on Vigilant monitoring of BSNL Funds

In the previous Circle council meeting it has been decided to nominate Inquiry officers at SSA level for EPF verification work to find out any misuse of BSNL funds . Accordingly, most of the SSA heads have nominated Inquiry Officers for the above work. . The Circle administration vide Lr. No. CVL/76-1/2009-13 dt. 10-06-2014 has informed the report of EPF verification work has not been received from many SSAs.. It may please be furnished whether report has been received from all SSAs AS ON DATE and copy of them may please be furnished to staff side
